

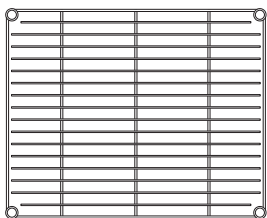

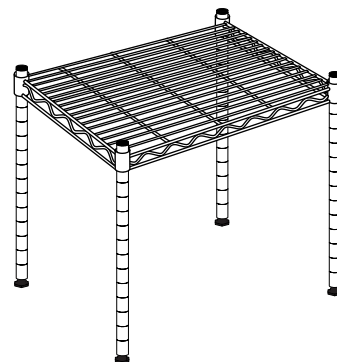

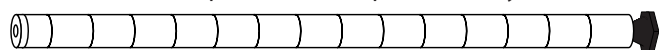

Less than 15 minutes.

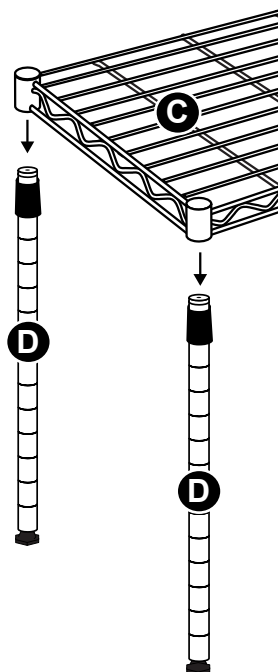
This product's intended use is for added shelving space anywhere in home or office.

Tools Needed: No additional tools required. A rubber mallet might help to seat shelves onto sleeves.

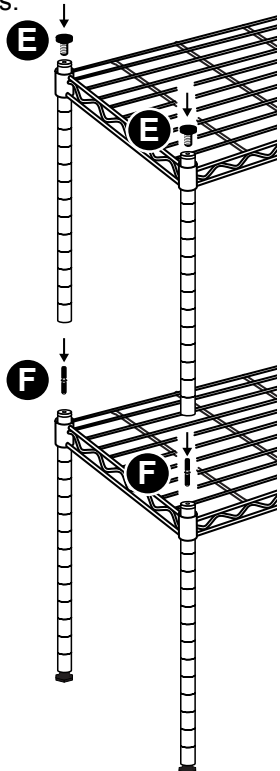


STEP 1. Start with poles (D) at the top (the end opposite the foot (B)). Snap two plastic sleeves (A) onto chrome poles at desired intervals. The sleeves are marked with a directional arrow to show proper placement. Use grooves on poles to ensure even shelf placement among the four poles.

STEP 2. Slide chrome poles (D) through shelf corners until shelf (C) rests firmly on sleeves. Push or gently tap the shelf down at corners to level shelf.



STEP 3. Determine if you are going to stack multiple shelves or use a single unit. If you stack multiple shelves screw the stacking screw (F) into the hole on the top of the four poles of assembled lower shelf unit. Before assembling top unit, take the feet off four poles and screw the poles onto lower shelf. Repeat steps 1 & 2 for top shelf unit. For the top unit screw plastic cap (E) into the holes on the top of the four poles.
